A new Raising Cane's Chicken Fingers location in Lakeville was approved during the June 7 City Council meeting. The business will construct a 3,703-square-foot convenience restaurant with a two-lane drive-thru. The proposed restaurant will have indoor seating for 74 and an additional 42 outdoor patio seats.

Mainstreet Coffee & Wine Bar has recently been purchased by Scott and Kiley Van Daalen and held a grand re-opening of the business on Saturday, July 3. The business is located at 20790 Holyoke Avenue in downtown Lakeville and has plans to reopen the wine bar in fall 2021.

Building Permits Report

The City has issued building permits with a total valuation of \$183,927,017 through June. This compares to a total valuation of \$156,705,893 for building permits issued through June of 2020.



The City issued permits for 267 single-family homes through June with a total valuation of \$84,385,000. This compares to

265 single-family home permits through June of 2020 with a total valuation of \$79,312,000.

The City has also issued 103 townhome permits with a total valuation of \$22,244,000 through June, compared to 65 townhome permits with a total valuation of \$11,742,000 during the same period in 2020.

Lakeville has issued the highest number of residential permits year-to-date in the Twin Cities followed by Woodbury, Cottage Grove, Otsego and Dayton.
