Weekly Review

- Hit and Run Traffic Accident reported at 16XXX Griffon Trail.
- Patrol responded to a neighbors dispute over a divided property fence.
- A 23-year old male was cited for Shoplifting at Fleet Farm.
- Vandalism/Property Damage reported at 5XXX Country View Trail.
- Officers responded to no less than eleven (11) Mental Health Crisis calls.
- Patrol arrested a 35-year old male for a Felony OFP Violation. The protected party claimed he wasn't there. Our officer had quite the surprise when he checked a bathroom under construction and found the suspect lying under a piece of plywood covering the tub!
- A bicyclist drove into the rear end of a parked vehicle on the 7000 block of 210th Street West and was transported to the hospital with minor injuries.
- At least nine (9) more unemployment scams were reported this week.
- Burglary was reported at 17XXX Kenyon Avenue.
- Talk about a diamond in the rough! Fraud Activity reported after the victim purchased jewelry from an unknown suspect, who was peddling jewelry out of his van. Now the victim believes the jewelry is fake.
- A 50-year old female was cited for Shoplifting from Target.
- Fraud Activity reported after the victim believed "apple support" was calling. She incurred approximately \$800 in losses.
- A 26-year old male was caught and cited with Theft and Tamper with Vehicle after he was called in as a Suspicious Person seen entering vehicles at 17XXX Kenwood Trail.
- Officers mediated a Domestic/Disputes in Progress between a father and a son.
- A stolen motorcycle was reported from 16XXX Kenrick Avenue.

- Patrol responded to a Traffic Accident at 17XXX Kenrick Avenue after the 21-year old male driver didn't make the corner, went up over the curb, rolled the vehicle a few times, and landed in a nearby parking lot. He was sent with medics for care.
- Officers were dispatched to a fire at 17XXX Eveleth Avenue. During the investigation, a 20-year old male suspect was identified, who admitted to the Arson, as well as the Arson and Burglary last week at an apartment complex and a home under construction. He was jailed on 1st Degree Arson.
- Fraud Activity reported after the victim have \$3,500 in gift cards to a scam artist posing as a Direct TV employee.
- A Warrant arrest, of a 29-year old male, was made on an active Felony Probation Violation.
- A victim received a phone call from the "police" and was told someone was using her name to try and rent a car out-of-state. As a way to protect her name, she was advised she need to provide \$500 in gift cards. She did and also provided her Social Security Number and other personal details.
- Vandalism reported at Casperson Park after a porta potty was found vandalized.
- A victim was scammed out of \$7,000 after a hacker took control of her new computer and convinced her to send gift cards to safeguard her account.
- Theft of jewelry reported from a home at 18XXX Judicial Way North.
- Officers were called out on Suspicious Activity at 17XXX Glacier Way. The reporting party witnessed occupants of a vehicle remove the license plate and drive over to Kwik Trip. The vehicle was located and stopped. It didn't have plates on it. The 21-year old male driver had pumped gas and left without paying. He was cited for Driving After Suspension and Theft.
- A 38-year old male was jailed for an OFP/DANCO Violation.
- Another Burglary/Damage to Property/Arson occurred at 5XXX 161st Street West.
