### Weekly Review

- Patrol mediated a Domestic/Disputes in Progress call involving a husband and wife.
- A Traffic Stop, at 181<sup>st</sup> Street West and Cedar Avenue, found the speeding driver impaired. He tested a .14 BAC and was charged with 4<sup>th</sup> Degree DWI and Driving After Revocation.
- Attempted Burglary was reported at 7XXX Lakeville Boulevard. The suspect(s) cut storage locker padlocks but were unable to get away with any product.
- A 28-year old male and a 43-year old male were cited for unrelated Misdemeanor Thefts after stealing from Fleet Farm.
- Patrol responded to no less than three (3) Mental Health Crisis calls.
- A car struck two bicyclists on Cedar Avenue, knocking them both over. One was transported to the hospital with minor injuries.
- Theft was reported from Highview Avenue and Dodd Boulevard. An unlocked shed was entered and equipment was stolen.
- A 44-year old male was arrested for Misdemeanor Domestic Assault after he struck his girlfriend.
- Burglary reported, from a home under construction, at 8XXX 188<sup>th</sup> Street West.
- Traffic Stop, on 185<sup>th</sup> Street West, resulted in an impaired driving arrest of a 37-year old male who provided a .231 BAC.
- After mediating a verbal Domestic, a second issue occurred at the same residence. That too was seemingly mediated, but the 33-year old female decided to go back a third time and threaten the male with a knife. She was jailed for 2<sup>nd</sup> Degree Assault and 1<sup>st</sup> Degree Burglary.
- Theft from Vehicle reported from 18XXX Jonesboro Court.
- Officers arrested a 54-year old male for an OFP/DANCO Violation.
- Vandalism/Property Damage was reported from Walmart after the victim came out of the store and found his car window smashed out.
- Theft from Vehicle reported from 16XXX Elm Creek Lane.
- Theft from a construction trailer reported at 8XXX 183<sup>rd</sup> Street West. Several tools were taken.
- A 44-year old female was arrested for 2<sup>nd</sup> Degree DWI, on 175<sup>th</sup> Street West, after testing a .275 BAC.
- A 30-year old female was involved in a minor Property Damage Crash, at Pilot Knob Road and 160<sup>th</sup> Street West, and arrested for 4<sup>th</sup> Degree DWI, after providing a .15 BAC.
- A routine Traffic Stop, on Cedar Avenue and 190<sup>th</sup> Street West, resulted in a 54-year old male being arrested for 1<sup>st</sup> Degree DWI, after providing a .18 BAC. He also was Cancelled IPS and had a B Card Violation.
