Weekly Review

- Patrol responded to a Property Damage Crash at 18XXX Kenrick Avenue. The driver was sitting in the car, in front of an empty storefront. She leaned down to clean something off her shoe and pressed the gas. Her vehicle crashed through the window into the building. Fortunately, there were no injuries reported.
- A 40-year old male was cited for Shoplifting from Fleet Farm.
- Patrol responded to at least six (6) Mental Health Crisis calls.
- Theft of a mountain bike reported from Falkirk Trail and Elm Creek Lane.
- Theft of a cell phone reported from Antler's Park.
- Parkview Elementary was vandalized with spray paint.
- A tow truck was reported Stolen from 20XXX Kenrick Avenue.
- Theft from Vehicle reported from 16XXX Elm Creek Lane after a laptop was taken.
- Theft of equipment was reported from a construction site at Cedar Avenue and 222nd Street West.
