Shed - Accessory structure including roof overhangs may not be located in easements.
- Materials used must be architecturally similar to the home. Sheds must not impede drainage.

Fence - All of fence construction, including post foundation, must be located entirely on fence owner's property.
- Fences connecting to an adjacent fence must get neighbor's permission. Fences must not impede drainage.
- The finished side/face of the fence shall face the abutting property or street.

Pool Fence - Fencing surrounding swimming pools must meet pool enclosure requirements of section 11-22-5. G of the City Code as well as general fencing requirements.
- Pool enclosure requirements include a minimum height of 4 feet, maximum 4-inch openings, and self-closing and self-latching gates.
