



Vermillion River Watershed Joint Powers Organization and City of Lakeville Irrigation System Improvement Financial Assistance Program

Instructions: To qualify, applicants must have had an irrigation audit completed by an EPA WaterSense certified irrigation professional as part of the City of Lakeville (City) and Vermillion River Watershed JPO Urban Water Conservation Program (VRWJPO). It is recommended system improvements be installed by an EPA WaterSense certified irrigation professional.

Improvements implemented prior to City and VRWJPO approval do not qualify for reimbursement. Associations are required to provide match to all implemented improvements. The following amounts are reimbursable:

- 75% of total product cost, up to \$750 per controller, for maximum amount of \$3,000, for EPA WaterSense Certified Smart Controllers
- 25% of total cost, up to \$500, for Other Recommended Efficiency Upgrades as outlined in the City and VRWJPO approved irrigation audit

The maximum cost-share that can be requested is \$3,500.
